

Introduction

This instruction describes in brief how you can add substances and components in Byggvarubedömningen's "Apply for assessment".

Since several of the certification systems that currently exist for properties require public reporting of content for the commodities and products included in a property, Byggvarubedömningen recommends that you provide the content of your product as public information. By providing information about substance content as public information, you will be able to increase the chance of users of our Web Service choosing your product for their property and logbook.

Tip! By reporting substances or components as "public", you can enable your product to be selected for more properties and projects/logbooks.

An assessment is based on the complete contents of a commodity or a chemical product on delivery stated as wt% of the entire commodity and the content must be reported according to the instructions in our [Appendix for declaration of content \(pdf\)](#).


1. General instructions

Regardless of the type of product for which you are applying for assessment, you can add “public” and/or “non-public” substances. If you apply for assessment of a commodity, you will also have the option to add information about substance content specified by component. For chemical products, there is the option to state the function of constituent substances.

You can find more information under each section regarding how to add substances for each type of product.

In brief, you add a substance or component by:

1: Clicking on one of the buttons



2: Pop-up window

A pop-up window appears, where you are urged to fill in what substance or component is involved and the content amount (wt%) to which the substance or component is included.



4: “Meter” for the extent of the content you have provided

A “meter” can be seen under the table with added substances and components. During the time that you report your content, the “meter” under your reported content will show the percentage of the product or commodity’s total content of what you have reported. Note that the meter only shows content you declare up to 100%, if you declare more than 100% this will not be reflected in the meter.

To meet Byggsvarubedömningen’s reporting requirement, at least 98% of the product’s content must be declared and the content must also be reported in accordance with our instructions: [Appendix for declaration of content \(pdf\)](#). In the image below, 30% of the content has been reported, and you then receive an indication that you have reported less than our reporting requirement.

For faster handling, please prepare the declaration of contents. The alternative to hand in declaration of contents under a Confidentiality agreement is connected with a higher assessment fee. Note! Many projects require that declaration of contents is made public, this is especially the case for buildings to be certified. Make your product more selling by adding the contents as public.

5: Response options

Under the "meter", there are three response options, the first of which is pre-filled. The available response options are that you can choose to report content as "Public" – which is the pre-filled option, "Non-public" or under a formal "Confidentiality agreement". Select the option that is appropriate for your current "Apply for assessment".


2. Add "public" substances

You will add a new public substance.

1: Click on the button "New public substance":



Weight percent of the substance in the component/raw material
This refers to the weight, in percent, of the substance that the component consists of.

You add a substance by searching for the substance in Byggvarubedömningen's database. If you cannot find the substance you are looking for, it is possible to add your own. At present, only Swedish words can be searched for in the list. Therefore, it is easier to search by CAS, EC or alloy number. If you do not find the substance you are looking for, you can add the name for that substance in free text in the box "Name of substance". Note that a clarification of the substance may be requested at a later stage.

In the box below, you can search by name, as well as by CAS, EC and alloy number. Various options will be shown in a scroll-down menu, where you can select the substance item required. Other information related to the substance item will be filled in automatically.

To enter your own substance (meaning that you are unable to find the item after the scroll-down list is shown), you should do the following: Enter the name of your substance. If the substance you want to add has an "Identifier", that is, a CAS/EC/alloy number, select this under "Type of value" and then enter the relevant number. If there

is no CAS/EC/alloy number, the box is left empty and you do not need to select an “Identifier”. Note that a clarification of the substance may be requested at a later stage.

Then select type of value, if the amount of the substance is precise, smaller/larger than or if the substance occurs within a range. Be careful about selecting “equal to” and/or “smaller than” because this could affect your assessment. If you select the range option, you will need to provide lowest and highest values.

4: Editing substance items in the table

If you want to change any information for the substances you added, you can move the cursor over the substance at the right-hand side of the table.

5: Yellow information triangle

To help you, some substances that you add will display a yellow information triangle. The yellow information triangle indicates that there is explanatory information for the selected substance item. You can find the information by moving the cursor over the yellow symbol. For example, this may explain how the substance item can be used, or provide clarification relating to further reporting of the substance to meet our reporting requirements.

If PVC is reported in concentrations from 2% and onwards, the type of plasticizer used must always be stated with CAS number and individual concentration. For PVC that contributes less than 2%, plasticizers that are covered by the Byggsvarubedömningen reporting requirements must be stated with CAS number and individual concentration. If the PVC that is used has not been softened, this needs to be stated in a comment. If correct information is lacking, this will be requested by the assessor, information provided may also be reconciled.

In the above example, the substance item “Polyvinylklorid, PVC” has been selected. The text in the information box provides the information how to fully meet the reporting requirements.

If you have already added a substance, you can find the same information in the table of added substances. This is also indicated by a yellow information triangle. You can open the information box by moving the cursor over the yellow information triangle.

6: The “Meter” shows the percentage of content you have reported



3. Add to “Non-public” substances

You should add to “Non-public” substances. These substances will not be displayed to the users of our Web Service, but will only be visible to our assessors.

1: Activate “Non-public” substances function

To be able to add “Non-public” substances, you need to active the “Non-public” substances function. Click on the response option that you want to provide information on substance content as non-public in the pink box under “meter”.



If information on “Non-public” substances is to be submitted from a third party or after a confidentiality agreement has been signed, follow the instructions in the pink box.

3: Click on the “New Non-public substance” button



4: A pop-up window for notification

A pop-up window will appear to bring to your attention that you are about to report a “Non-public” substance. Click on “Confirm”.

I am presenting a substance as "Non-public" and do therefore accept that information is stored in Byggvarubedömningen's Web Service but treated in Non-public format, meaning that unauthorized cannot access this information.

Due to this substance being "Non-public", I also have the possibility to show public, "masked information" for the same substance. The "masked information" will be visible for all users of the Web Service.

We must make sure that your Non-public information is not disposable for unauthorized. Due to this, we ask you to consider this:

- Your information about Non-public substances (or documents) is not accessible for anyone but Byggvarubedömningen after submitting the application.
- Your Non-public information will not be visible in your saved draft if you save a draft before submitting. However, you can see the proportion of the content.
- Your Non-public information will not be visible if you need to complete your assessment. However, you can see the proportion of the content. Additionally, the name of Non-public documents is "masked" as well and will not be visible. The document is available with original name in our Web Service.

We recommend you print your application before you save or submit it - due to the possible scenario that you would like to see your Non-public documentation after saving a draft, submitting the application or if you need to complement your application.



If anything is incorrect, for example, the substance that has been added or the content of the substance, this can be edited later, see item 7.

- Grey text is information to be handled as “non-public” and will only be used for assessment of the product.




4. Report information from third parties or through confidentiality agreements

If you cannot report the content or parts of the content of your product as "Public" or "Non-public" information, there are the following two options:

- I. Report information about the content through a third party.
- II. Only report information after a formal confidentiality agreement has been signed with Byggvarubedömningen.

1. Report information from third parties

If the reporting of the substance content is to be made through a third party, click on the option that appears in the image below. You then follow the instructions provided.

7. Two examples of reports

Here are two examples of how substance content can be reported.

Example 1, Reporting a commodity

You are to report the content of a commodity.

Product A is a commodity that comprises 50% metal, 40% wood and 10% plastic.

Note that if the substances that are part of your product are included in the candidate list, the substances must be reported at component level (meaning you must report which component contains the substance).

You can choose to report the content of Product A as three public substance items, as shown in the image below. If you want to, you can describe each substance's function in your product by specifying it. In the image below, no function has been added.

Example 2, reporting of a chemical product

You are to report the content of a chemical product. Your chemical product includes the substances that you want to show as “Public” in Byggvarubedömningen’s Web Service, but the substances that you want to be “Non-public” are also included. When you are going to report the content of chemical products, you report the content that is contained in the unhardened product (before application). The substances reported in a safety data sheet must also be provided in the application template.

Product b is a chemical product comprising 40% water, 40% filler and 20% additives since it is unhardened.

We begin by reporting the substances that are “Public”. They can be seen in the table below, alongside the function that the substances fulfil in the chemical product. Please note that the table is “blue-shaded”.
